6	The Council received the following updates on Council Business and correspondence:			
	a) Caretaker tasks. Cllr Watson reported that the grass needs cutting at Hartwith Bank and in			
	Smelthouses. He proposed the caretaker clean the war memorial in advance of			
	Remembrance Day, seconded Cllr Thornton, <b>carried</b> . Cllr Watson also advised he had been			
	in touch with the church regarding the Remembrance Day service. <b>RESOLVED</b> : Clerk to liaise with the Vicar. <b>RESOLVED</b> : additional wreath to be ordered to commemorate those who			
	returned home from WWII.

	b) The Clerk presented the data from a four-month period for the two Vehicle Activated Signs in			
	the parish to the Council, with an analysis:			
	85% of vehicles passing the VAS located opposite Summerbridge Methodist Church were			
	travelling at or below 30 mph. The average speed vehicles travelled was 25.3 mph. The			
	average speed of those travelling exceeded the 30 mph speed limit during the period was 33.6			

mph. Most of the speeding happened between midnight and 5.30 am and the pattern was constant every week. The data shows that 97% of vehicles are travelling below the speed typically needed to trigger a speed camera.

85% of vehicles passing the VAS located on Hartwith Bank were travelling below 24 mph and the average speed was 20 mph. Only 0.2% of those travelling past the VAS during the 4-month period exceeded the speed limit and their average speed was 32.5 mph. This occurred during the early hours of the morning. The data shows that 99% of vehicles are travelling below the speed typically needed to trigger a speed camera.

The Councillors noted that the introduction of the VAS appears to have had a positive impact on speeding in the parish, but it will be important to monitor the pattern over the coming months.

**RESOLVED**: VAS at Hartwith Bank to be relocated to East View Terrace to capture speeds of vehicles travelling from Burnt Yates into Summerbridge, VAS at Summerbridge Methodist Church site to be turned around to capture speeds of vehicles travelling through Summerbridge from Pateley Bridge towards Burnt Yates. Date of change to be confirmed.

c) The consultation on a new Council Tax Reduction Scheme for North Yorkshire was noted.
